## COPA projected to decrease in 2019

Electric cooperative member owners have a financial stake in the business. That financial stake includes adjustments for changes in the cost of power and returns of dollars that were over-collected the previous year.

PRECorp's financial forecasters work throughout the year to monitor the costs members are paying for power. It shows up under the "Power Cost Adjustment" line item on your bill.

PRECorp purchases its power from Basin Electric Cooperative, headquartered in Bismarck, N.D., and distributes that electricity to its members throughout northeast Wyoming.

### How is COPA determined?

Each year PRECorp uses sales projections to determine how much revenue is needed to recover the costs of the power purchased from Basin. Basin Electric is making no changes to its rates in 2019. A portion of the revenue for the cost of power comes from the base rate in the most recent general Cost of Power Adjustment (COPA) filing approved by the Wyoming Public Service Commission.

The COPA is used annually to ensure that PRECorp recovers the actual cost of power it incurs each year. There are two parts to the COPA rate: Estimated future power costs, and a "true up" of prior year's power costs.

Projected sales and power costs are used to estimate future power costs for the COPA each year, and are just that - only an estimate.

The "true up" part of the annual calculation of the COPA amount looks back to the prior year. This look-back compares the revenue collected to cover wholesale power costs to the actual costs that PRECorp incurred to buy that power. Amounts collected above the costs from a rate class are returned to the members of that rate class by lowering the COPA.

### Bottom line:

Although specific numbers had not been finalized at press time for this publication, all COPA factors are currently projected to decrease for 2019. This means members will see a slight decrease in the COPA charges on their bills beginning in February.

When the final COPA is calculated, PRECorp will file an application with the Wyoming Public Service Commission (PSC), requesting an approval with an effective date of January 2019. All application materials will be available on our website at [www.precorp.coop/public-service-commission](http://www.precorp.coop/public-service-commission). More information will be shared in the upcoming PowerLines bill insert and the December PRECorp News, including the estimated percentage decrease and progress of the PSC filing.





# SAFE DÉCOR FOR A HAPPY HOLIDAY SEASON

It's almost time to deck those halls! Statistics show that home fires and electrical accidents typically increase during winter months, so keep these holiday lighting tips in mind for a safe holiday season.

**Carefully inspect all electrical decorations before you use them. Cracked or damaged sockets and/or loose or exposed wires can cause serious shock or start a fire.**





**Consider purchasing LED lights, which use less energy and run cooler than traditional incandescent lights.**

**Never mount or support light strings in a way that might damage the cord's insulation.**



**Make sure that cords are not pinched in doors, windows or under heavy furniture, which could damage the cord's insulation.**

**Always unplug electrical decorations before replacing bulbs or fuses.**



**Turn off all indoor and outdoor electrical decorations before leaving home or going to sleep.**

# PRECorp announces 2019 scholarships

Powder River Energy Corporation facilitates many scholarships for eligible high school and college students from northeast Wyoming.

Descriptions and deadlines for each scholarship follow:

## **Basin Electric Scholarship - \$1,000**

**The filing deadline for the Basin Electric Power Scholarship is February 1, 2019.**

## **Swanda Scholarship - \$2,500**

To a Crook County High School senior planning to enroll in agricultural or animal science studies a university or vocational/technical school in Wyoming, North Dakota, or South Dakota. Seniors at Sundance High School receive preference this year on the pro-

gram's rotating schedule. However, all seniors from Crook County are encouraged to apply. **The filing deadline for the Swanda Scholarship is March 29, 2019.**

## **Powder River Energy Corporation/Foundation Scholarship - \$1,500**

To qualifying seniors and college students from 14 high schools and at-large students in its service territory. Applicant's parents or legal guardians must be PRECorp members.

**The deadline for Powder River Energy Corporation Scholarship is March 29, 2019.**



## **Cooperative Youth Leadership Camp**

The Powder River Energy Board of Directors sponsors an all-expense-paid experience for high school age students of PRECorp members. **Turn the page for the application.** Up to five local youth are selected to represent PRECorp at the Cooperative Youth Leadership Camp in Steamboat, CO, July 13-18, 2019. ## Have a medical necessity?



In an effort to better serve our members with special health care needs, PRECorp is requesting information from our members who may have electricity-dependent residential medical equipment such as oxygen or dialysis machines.

Typically this information is gathered when members join the Cooperative and sign up for PRECorp electrical service.

However, if members have obtained the medical equipment since joining the Cooperative, members may want to share that information with us.

The purpose for knowing this information is to notify members with medical necessities of scheduled outages that would affect their service.

Members will need to provide a doctor's note for our files explaining the medical necessity. Other information that will be needed is their physical address, member number, meter number, and emergency contact phone number.
