

# UNDERSTANDING YOUR BILL

Powder River Energy Corporation has recently redesigned your monthly bill to make it more user-friendly. We're also providing tips on reading your bill. The bill below is a general example of a residential bill. It does include line items that may not appear on your bill. Your bill, depending on the type of service, number of accounts, and line items, may vary slightly.

Call your Customer Service Representative for specific questions.

**NEW:** The table just below the graph includes average high and low temperatures for the month. The bold "M" in the graph indicates the usage for this billing and the Avg Hi and Avg Lo Temps for the month of March. If your "Usage From and To" dates (see B) include days in the previous month, you will also want to check the Last Month Avg Hi and Avg Low Temps as indicated in the chart (see A).

- 1. KWH ENERGY CHARGE:** The charge for electricity used.
- 2. BASIC CHARGE:** A set fee for maintenance and line costs regardless of usage.
- 3. POWER COST ADJUSTMENT:** Adjustment for changes in the cooperative's cost to purchase power. Normally adjusted annually and is billed to you as a fixed charge per your KWH usage.
- 4. ROUNDUP CONTRIBUTION:** Participating members "roundup" each of their accounts to the nearest dollar. These monies are used by the PRECorp Foundation fund for charitable contributions.
- 5. TAX:** State and County.
- 6. YTD ROUNDUP CONTRIBUTION:** Summary of YTD Operation Round Up® campaign contributions for participating members.
