



# Electrical Lineworker Scholarship Guidelines



## Objective:

To encourage, promote, and educate lineworkers for enduring and rewarding careers.

## Policy:

### I. Availability

Scholarships may be awarded to applicants who plan to attend an approved lineworker training program.

- A. The application deadline is February 28, 2025.
- B. The scholarships are available for up to \$7,000.
- C. The scholarships are available to all qualified applicants.

### II. Selection Process

- A. Powder River Energy Corporation (PRECorp) will be responsible for providing information to high schools in their general area. PRECorp will be responsible for advertising scholarship application information in local media.
- B. Candidates must submit applications to PRECorp. Email to: [communications@precorp.coop](mailto:communications@precorp.coop); or mail to: PRECorp Lineman Scholarship, PO Box 930, Sundance, WY 82729
- C. Scholarship recipient and alternate will be selected according to the following:
  1. Scholarship applications will include an application form, a resume detailing employment experience and duties, specialized skills, and three (3) letters of recommendation.
  2. Application deadline is March 1 to be eligible for funds in the current academic year.
  3. PRECorp may choose one (1) or more qualified recipients for the scholarship.
  4. PRECorp may award an alternate the scholarship if the original applicant selected is unable to use the scholarship.

### III. Payment

- A. The first scholarship payment will be made when the student enrolls in the next available session or semester of an approved regional lineworker training program.
- B. The scholarship may be paid in installments based on the number of semesters; and will be paid directly to the student's account at his/her school of choice.
- C. Verification of enrollment and GPA must be sent to PRECorp upon completion of each semester/session and prior to release of additional scholarship funds. If enrollment verification and GPA are not submitted, the funds will not be issued.
- D. No further scholarship money will be awarded in the event the student fails to complete the program or fails to maintain a 2.5 GPA, at which time the student will be asked to repay the scholarship funds previously received.
