Basin Electric announces 2025 rate increase

PRECorp's wholesale power supplier Basin Electric will implement an increase in the cost of the power it sells to PRECorp beginning in 2025. As of press time the estimated increase is between 9% and 10%. However, the impact on individual members' bills is still being evaluated.

The increase is tied to Basin's long-term efforts to increase its electric generation and distribution resources amid rising demand for power in the central and western United States.

"Basin is responding to pressure to meet demand for power from growing industrial and residential areas in its service territory," said PRECorp CEO Brian Mills. "Pair that with regulatory pressure to close down its coal generation fleet, Basin is working proactively to add alternative generation and distribution systems so they do not have to purchase power on a competitive open market."

Mills said the long-term benefits to Basin's members are rate stability as the wholesale power supplier works to control its own generation and pricing structure. Basin's generation mix includes coal, natural gas, wind, and solar. While coal generation has remained relatively stable, the demand for more electricity from industrial members and data computing centers has increased dramatically since the beginning of this decade.

Basin, an electric generation and transmission cooperative, is not owned by shareholders. Instead, Basin's member cooperatives hold a financial stake in the company and,

therefore, invest through rates and, over time, receive capital credit returns or dividends on those investments. "The cooperative model of capital credits and the financial strategy of deferred revenue has enabled Basin and PRECorp to lessen the impact of this rate increase," said PRECorp Chief Financial and Administration Officer Bill Mertz.

"We were able to save up these dollars from previous years and leverage them to ensure this increase has less of an impact in 2025. Those funds bought us some time so that members can prepare for the increase to hit their bills later in the year when usage is lower."

"We understand any increase impacts every member whether they have high power usage or not. The last rate increases were in 2016 and 2020. This is a time for members to consider PRECorp's variety of programs to help control usage and costs," Mills said.

PRECorp offers Budget Billing, Heat Rates, Energy Audits, prepaid metering, and other arrangements to help members navigate their individual needs.

You pay for the electricity you consume each month, but there are additional factors that impact your energy bills.

Fuel Costs

Before electricity can be delivered to your home, it must first be generated at a power plant or from a renewable source. The cost of fuels used to generate electricity fluctuates, which is why you see a power or fuel charge on your monthly bill. This monthly charge covers cost fluctuations without having to continually restructure electricity rates.

Service Costs

Your bill includes a monthly service charge, which recovers part of the co-op's ongoing investments in poles, wire, meters, system maintenance and additional costs necessary to provide electric service.

Weather

When temperatures soar or dip, your cooling or heating equipment must run longer and at maximum capacity, which can greatly increase your energy use. Extreme temperatures can also affect electricity market prices. When the need for electricity increases due to extreme heat or cold, the price of power typically rises.

Energy Consumption

This is the amount of electricity you use each month to power your home's cooling/heating system, appliances, lighting, electronics and more. The amount of electricity you consume is measured in kilowatt-hours, or kWh. You have control over how much energy you use, which can ultimately help manage your monthly costs.
