## NOTICE OF APPLICATION (Issued May 3, 2019)

- 1. Pursuant to the Wyoming Administrative Procedure Act and the Wyoming Public Service Commission's (Commission) Rules and Regulations, notice is hereby given of the Application of Powder River Energy Corporation (PRECorp or the Company), for authority to implement a new non-residential heat rate tariff.
- 2. PRECorp is a public utility as defined in Wyo. Stat. § 37-1-101(a)(vi)(C), subject to the Commission's jurisdiction pursuant to Wyo. Stat. § 37-2-112.
- 3. On April 30, 2019, PRECorp filed its Application requesting authority to implement a new non-residential heat rate tariff.
- 4. PRECorp is requesting authority to implement a new non-residential heat rate tariff applicable to all non-residential customers. The non-residential heat rate tariff will be applicable only to qualifying and separately-metered resistant space heating loads. PRECorp states in its Application that there are no proposed changes to the load served under the standard existing tariff. The Company also states its Member customers will be able to participate in the tariff on a voluntary basis.
- 5. This is not a complete description of the Application. Interested persons may inspect the Application at any PRECorp Wyoming business office, or at the Commission's offices in Cheyenne, Wyoming, during regular business hours. The Application can also be viewed at www.precorp.coop.
- 6. Anyone desiring to file a public comment, statement, intervention petition, protest or request for a public hearing in this matter must so file with the Commission in writing on or before June 3, 2019. Any intervention request filed with the Commission shall set forth the grounds of the proposed intervention or request for hearing as well as the position and the interest of the petitioner in this proceeding.
- 7.
