#### IV. Applicant Certification and Equipment Release

I/we have willfully furnished information to PRECorp for the purpose of participating in the Powder River Energy Corporation Heat Rate Program. I/we understand PRECorp personnel may review the information provided above, my past account activity, credit history, or other information while processing this request. I/we authorize PRECorp to contact any individuals or institutions listed on this or other application forms, if required, to assist in completing this request.

Furthermore, I/we understand/agree:

- The Residential Heat Rate (RHR) is only applicable to residential members of PRECorp who have permanent electric resistance heat and/or electric heat pump space heating systems. I/we understand that this rate is not available to seasonal loads or to Residential Time-of-Day (TOD) customers.
- Agree to have a PRECorp approved meter installed and additional equipment required by PRECorp necessary to meter the electric heat installation loads identified above separately from other loads.
- PRECorp has provided information regarding the requirements necessary to install the Heat Credit Meter Base, specified on the PRECorp specifications which I/we are responsible to complete before PRECorp will install the Heat Credit Meter.
- I/we are responsible to provide all additional materials (e.g., conduit, fittings, wires, and any other equipment) required to complete the installation of the Meter Base.
- I/we are responsible to ensure proper signatures are secured and other information is completed on the attached form to be returned to PRECorp before PRECorp personnel will install the Heat Credit Meter.
- I/we are responsible for securing all required permits and inspections related to the installation of the Meter Base and related interconnections.
- I/we am/are required to complete the installation of the Meter Base and related interconnections (PRECorp does not require the use of a licensed electrician) and to contact PRECorp within ninety (90) days of the date on this form. If I/we have not completed the installation and contacted PRECorp to schedule the installation of the Heat Credit Meter, PRECorp may bill my/our account the full amount for the Meter Base which will be made due and payable immediately on my/our next billing statement.
- I/we acknowledge that we have received the Meter Base from PRECorp and release PRECorp from any further obligation to provide the Meter Base.
- PRECorp, its personnel or designated third party, reserves the right, at any time, to inspect the installation of the Meter Base and/or related interconnections. Should PRECorp personnel find that the installation does not conform to any PRECorp standards, then PRECorp will inform me/us of any deficiency(ies). I/we am/are responsible to ensure the installation is corrected and will contact PRECorp once remedies are completed. I/we understand that my/our account will be billed \$75 for each additional visit by PRECorp personnel which is required as a result of any deficiency, to be due and payable immediately, on my/our next billing statement and I/we agree to pay the \$75 charge per visit.
