# Unclaimed Capital Credits deadline is September 10

At <u>www.precorp.coop/capital-credits</u> is a list of members or former members who are owed patronage capital (capital credits) for the fiscal year 2018 and for whom PRECorp does not have a current or deliverable mailing address.

PRECorp's bylaws require that two years after capital credits are retired and remained unclaimed, the members, or former member, be sent a letter attempting to locate them and list of names be published in a local newspaper. If the capital credits remain unclaimed sixty days after notice, the capital credits are then forfeited by the member and gifted to the cooperative.

The list was published in two July editions of the Gillette News Record. Members or former members who would like to see if they are on this list should view it on-line and, if necessary, contact PRECorp at 1-800-442-3630 BEFORE Friday, September 10.

Upon positive identification, unclaimed capital credit money will be issued to the member or former member in the form of a check.

Please allow two weeks for processing.

After September 10, the remaining unclaimed capital credits will be considered forfeited and gifted to the cooperative. Gifted funds are permanent equity of the cooperative which are used to benefit PRECorp's remaining membership as a whole.

Currently the gifted capital credits are used to fund PRECorp's scholarship program and other civic and community involvement programs.

In this way, even though the capital credits are not being returned to the members who earned them, the money is still being returned to communities that PRECorp serves.

### ELECTRICAL SAFETY S FOR HUNI

This hunting season, we encourage all members to be aware of electrical equipment and take necessary precautions while hunting. Keep these safety tips in mind as you enjoy the great outdoors.



Take notice of posted warning signs and keep clear of electrical equipment.



**Do not** shoot at or near power lines or insulators.



**Know** where power lines and equipment are located on the land where you hunt.



Be especially careful in wooded areas where power lines may not be as visible.



**Do not** place deer stands on utility poles or climb poles. Energized lines and equipment can conduct electricity to anyone who comes in contact with them, causing shock or electrocution.

**Do not** place decoys on power lines or other utility equipment. Any non-electrical equipment attached to a pole can pose an obstruction and serious hazards to our line crews.
