MARCH 2016

The Regular Meeting of the Board of Directors of Powder River Energy Corporation was called to order at 8:30 a.m. on Tuesday, March 22, 2016, in Sheridan by President Walt Christensen. All members were present.

Financials

System sales for January 2016 are down 14.9% compared to January 2015. Chief Finance and Administration Officer Joanne Kolb gave an update on kilowatt hour sales projections compared to the budget.

CEO Report
