The Regular Meeting of the Board of Directors of Powder River Energy Corporation was called to order at 9:30 a.m. Tuesday, May 16, in Gillette, by President Walt Christensen. All members were present except Paul Baker and Reuben Ritthaler.

Financials

CFAO Joanne Kolb gave an update on 2017 sales and expenses compared to budget. Year-to-date system sales for March 2017 are up 2.1% compared to March 2016. March year-to-date resulted in a positive operating margin of approximately \$497,315, which is over budget by \$270,379.
